Methodology of the Audit

Data were collected from all teaching departments, the administrative office, the NSS office, student representatives from different clubs and college unions, the Vaikhari Centre and V. T. Pathanakendram using a questionnaire. After that, a meeting with IQAC and the heads of all departments was held, and the observation was finalized.

Observation

Criteria I – Curricular Aspects

- In the academic year 2022-23, the Institution provided 19 courses, including certificates, diplomas, and value-added programs.
- During this year, a significant 19 courses were attended by students, with 950 successfully completing them. This accounts for 95.86% of the student population benefiting from these programs.
- VTB College successfully integrated crosscutting issues of Professional Ethics, Gender, Human Values, Environment, and Sustainability into its curricular and Cocurricular activities.
- In 2022-23, 35.73% of students actively participated in project work, internships, and industrial visits.
- The *Vaikhari* Centre for Research in Kerala Heritage develops a deep appreciation for the values of our heritage among students.
- The Institution collects feedback from stakeholders and provides action-taken reports on its website.

Criteria II – Teaching, Learning and Evaluation

- In the academic year, 84.81% of sanctioned Seats are filled, and 89.71% of Reserved seats are filled against the reserved seats.
- Approximately 94.44% of full-time teachers hold NET/SET/Ph.D. qualifications, underscoring the solid academic foundation of the faculty. The student-full-time-teacher ratio remained at 26.38 for the academic year.
- A total of 80.69% of the students qualified for the UG/PG examination in the year.
- Student-centric and ICT-enabled learning experiences:

Various instructional tools (G Suite, Google Classroom, Google Meet, Zoom, WhatsApp and Telegram) and Assessment tools such as quizzes and Kahoot were used.

• Internal Assessment System:

Internal assessments follow University regulations and employ an Internal Examination Committee. The continuous assessment components, such as assignments, seminars, or Viva, are the responsibility of individual teachers. The internal marks are uploaded after the students check them, and grievances are redressed promptly.

• Outcome-Based Education (OBE) implementation:

Programme Outcomes (POs) and Course Outcomes (COs) are communicated through the website, classrooms, and departments. In the evaluation system, POs and Cos are identified through the question papers.

Criteria III – Research and Extension

- VTB College establishes a commitment to research and community engagement, establishing a comprehensive ecosystem for knowledge creation and dissemination.
- VTB College has fostered a thriving ecosystem for IKS through the dedicated Centre *Vaikhari*.
- The college is provided with an innovation ecosystem through the Young Innovation Programme (YIP) and ED Club.
- Two of our students have completed the Voice of Stakeholder (VoS) training programme as part of the Young Innovators Programme (YIP)
- *Vaikhari* Centre for Research in Kerala Heritage actively promotes Indian Knowledge Systems.
- This year, the Institution received grants totalling INR 13,30,455 as the second instalment of the UGC STRIDE project for research-related activities.
- A total of 9 workshops, seminars, and conferences, specifically in entrepreneurship, IPR and research methodology, were conducted during the academic year.
- Faculty members published an impressive total of 8 research papers in journals during the academic year.
- Faculty members contributed significantly to academia by publishing 14 books, chapters in edited volumes, and papers in national/international conference proceedings.
- The Institution initiated 28 extension programmes through NSS, Staff Club, etc.
- The Institution has received 9 Awards for NSS Unit, Programme Officer and Volunteer. Various other awards and recognitions were received for the Institution's impactful extension activities and its dedication to social responsibility.
- There are 11 new MoUs, collaborations/linkages for Faculty exchange, Student exchange, Internship, Field Project, On-the-job training, research and other academic activities undertaken by the Institution during the academic year.

Criteria IV – Infrastructure and Learning Resources

The Institution prioritizes infrastructure development guided by the directives of its Internal Quality Assurance Cell (1QAC).

• This year, the college added a yoga centre.



- Regularly updated desktops, laptops, and printers in all departments.
- Campus network for seamless communication and data sharing.
- The computer lab was renovated.
- Constructed a Media lab with facilities for developing E-content

Criteria V – Student Support and Progression

- Approximately 59.33% of students benefitted from scholarships and free ships, enhancing accessibility to education during the 2022-23 academic year.
- The students were provided with various opportunities to build their capacities. The Institution has organised 2 ICT and computer-related training, 3 language and communication skill development classes, 6 life skill classes and 5 soft skill development classes.
- In 2022-23, 61.71% of students received guidance for competitive examinations and career counselling.
- VTB College already has a grievance mechanism, and it has been improved in the year with respect to time for redressal.
- 35% of outgoing students are placed or progressed
- Among the outgoing students, 7 students have qualified for state/ national/level qualifying examinations.
- During the year, 23 medals were secured by the students for their outstanding performance in sports and arts.
- The number of sports and cultural programs in which students of the Institution participated during the year is 48.
- The Alumni Association financially supports meritorious students through scholarships.
- Alumnus act as resource persons in workshops/ conferences/seminars.

Criteria VI - Governance, Leadership and Management

- VTB College demonstrates a comprehensive alignment between governance and its vision/ mission, fostering an atmosphere infused with values and cultural heritage.
- VTB College's governance structure and decisions are guided by its vision and mission.
- Orientation on the Indian Knowledge System (IKS) and the preparedness towards the implementation of NEP. In the academic year 2022-23, the research related to IKS under UGC STRIDE Component 1 is completed.
- The college implements the strategic plan through a decentralized administration through diverse committees and adherence to regulations.
- A comprehensive performance appraisal system, effective welfare measures, and career development opportunities promote staff efficiency and enthusiasm.
- The institution tries to find funding from various sources, and this year, the college conducted internal audits for transparency and accountability.
- E-Governance: In the year, the Institution changed the e-governance for various academic functions, enhancing transparency.
- Out of the total faculty members of the Institution, 47.22% were provided with financial support to attend conferences/ workshops and towards membership fees of professional bodies.



• Out of the total staff (teaching and non-teaching) of the Institution, 68.18% had attended FDP, MDP, and Professional Development/Administrative training programs during the year.

Criteria VII – Institutional Values and Social Responsibility

- In 2022-23, the gender audit report reflects the women empowerment and gender equity programmes conducted in the Institution.
- The college has a "Gender Policy" that infuses all activities, fostering an environment that discourages discrimination and harassment.
- The Women's Development Cell has played a vital role in organizing various awareness programs.
- The Institution successfully integrated gender sensitization into curricular and cocurricular activities. The Institution has arranged facilities for women. The Institution also has an Internal Compliant Committee.
- The college's Green policy reflects a commitment to environmental sustainability programs and various initiatives like green audits and energy audits.
- VTB College actively promotes diversity across cultural, regional, linguistic, and socioeconomic dimensions. The college organises co-curricular programmes for inclusivity through various clubs and NSS.
- Best practices highlight the Institution's commitment to Indigenous Cultural heritage, environment sustainability and social welfare.
- *Vaikhari* Centre for Research in Kerala Heritage has actively conducted programmes on the Indian Knowledge system and Kerala cultural heritage through the UGC STRIDE project and other activities.
- *Spandanam* The programme made a positive impact on society and the environment, fostering responsible citizens who contribute to sustainable development.
- V T Padhanakendram stands as a distinctive programme that aims to study social transformations by focusing on V.T. Bhattathiripad's contributions to social reform and education and women's empowerment.

Summary of Audit Report

The Institution offers a sufficient number of courses, including certificates, diplomas, and value-added programs. The number of projects and internships is also adequate. The Institution's feedback mechanism effectively communicates with stakeholders. The internal assessment system and student-centric approaches are satisfactory. The Institution has progressed in implementing Outcome-Based Education (OBE) by publishing Program Outcomes (POs) and Course Outcomes (COs) on its website. The ecosystems for innovation, Indigenous Knowledge Systems (IKS), and Intellectual Property Rights (IPR) have been improved this year. A media lab has been constructed, and the computer lab has been renovated. Sports and cultural activities have been revamped in the post-pandemic period. The Institution was ranked in the NIRF rankings, and its IKS-related programs were considered noteworthy. The Institution has adequate gender equity programs and social commitment initiatives.



Recommendations

- \checkmark Modify the vision and mission of the institution.
- ✓ Outcome-based education (OBE) must be implemented using OBE-based evaluation.
- ✓ The Institution should increase its IT facilities to achieve 100% ICT-enabled classrooms.
- ✓ This year, the Institution has significantly enhanced its academic infrastructure, cocurricular and extra-curricular facilities, and IT facilities, achieving 100% ICT-enabled classrooms.
- ✓ The VT Museum and Archaeological Museum require improvement through proper exhibiting methods.
- \checkmark An online grievance form should be made available on the website.
- ✓ The Institution needs to upgrade its sports facilities, including the construction of cricket and football grounds and renovation of the gym and volleyball court.
