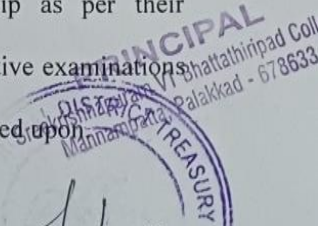



J. Governing Law




